Reynolds School District has concluded its evaluation of the proposals received and interviews held among finalists for the above referenced RFP.

- 3. Cedar Mill Construction Co., LLC

Because the District received fewer than 3 complete bids for several scopes of work, on-call contractor services exceeding \$30,000 will be publically procured, per the requirements identified by the Invitation to Bid on the following:

- 2. HAVC

**Per Oregon Administrative Rules 137-049-0395**, Reynolds School District shall, seven days henceforth of this Notice, direct negotiations toward obtaining a written agreement on:

(A) The Contractor's performance obligations and performance schedule;

(B) Payment methodology and a maximum amount payable to the Contractor for the specific services required under the Contract that is fair and reasonable to the Contracting Agency as determined solely by the Contracting Agency, taking into account the value, scope, complexity and nature of the specific services; and

(C) Any other provisions the Contracting Agency believes to be in the Contracting Agency's best interest to negotiate.
