(Oregon State Hair Design Program Track)

Dear Students and Parents,

Welcome to the **Introductory 1st Year of Cosmetology – Hair Design!** This program is designed to provide high school students with a strong foundation in the field of cosmetology while meeting the **Oregon State Board of Cosmetology requirements** for Hair Design licensure.

Cosmetology is more than just hairstyling—it's a combination of **science**, **creativity**, **and professional skills**. This first year introduces students to essential theory, hands-on practice, career development, and Oregon state laws that guide safe and ethical practice.

Program Goals

By the end of Year 1, students will:

- Gain foundational knowledge of hair cutting, styling, coloring, and chemical services.
- Develop strong professional habits in sanitation, hygiene, and client care.
- Learn about Oregon laws, rules, and licensing requirements for cosmetologists.
- Practice career-readiness skills such as communication, professionalism, and customer service.
- Begin supervised **hands-on practice** in a simulated salon environment.

Oregon State Requirements (Hair Design)

To become licensed in Oregon as a Hair Designer, students must complete:

- 1,110 instructional hours
- 455 practical operations (verified skill demonstrations)
- 20-hour Career Development
- 20 hours Oregon Laws & Rules

In this first year, students will complete approximately 555 hours of instruction, covering:

- \sim 200–250 practical operations
- All Career Development and Oregon Laws & Rules training

Course Outline - Year 1

Unit 1: Orientation & Foundations

- Introduction to cosmetology careers
- Oregon laws, rules, and ethics (20 hrs)
- Professional image and communication
- Career development, goal setting, and workplace readiness (20 hrs)

Unit 2: Health, Safety & Sanitation

- Infection control and bloodborne pathogens
- Proper use and cleaning of tools/equipment
- Client protection procedures

Unit 3: Tools & Basic Skills

- Comb, brush, scissors, clippers, and styling tool use
- Sectioning, draping, and consultation skills

Unit 4: Haircutting & Styling

- Basic haircutting techniques (blunt, layered, texturizing)
- Wet styling: finger waves, pin curls, roller sets
- Thermal styling: blow-drying, flat ironing, curling

Unit 5: Hair Coloring & Chemical Services

- Basic theory of color and lightning
- Introductory color applications
- Perming and chemical relaxing basics

Unit 6: Salon Experience

- Simulated salon practice with mannequins and peers
- Professional etiquette and time management
- Integration of client service and technical skills

Assessments

- Theory tests and quizzes (written knowledge)
- **Practical evaluations** (hands-on demonstrations)
- Portfolio building: tracking hours, operations, and reflections
- Class participation and professionalism

Expectations

- Attendance is critical: State requirements demand documented hours for licensure.
- **Dress Code**: Students must wear appropriate cosmetology attire and closed-toe shoes, no hoodies, no beenies
- **Professional Conduct**: Respect for tools, classmates, instructors, and clients at all times.
- Engagement: Active participation in both theory and practice ensures mastery of skills.

Year 1 Schedule

Students will progress through:

- Weeks 1–2: Orientation, sanitation, laws/rules, career development
- Weeks 3–8: Haircutting, styling basics, tool handling
- Weeks 9–12: Color and chemical theory with beginner practice
- Weeks 13–18: Simulated salon, refining skills, completing operations

We are excited to guide students on their journey into cosmetology! By the end of Year 1, students will have a solid foundation in the science and art of Hair Design, preparing them for advanced skills and client services in Year 2.
