Required Textbooks/Materials: School laptop, laptop charger

Course Description – This is an introductory course where students learn the basic terminology, location and purpose of major components of the automobile including the engine, transmission, brakes, suspension, steering, electrical and air conditioning systems. 2 and 4 stroke gas engines are discussed at length, 4 stroke diesel engine theory is briefly discussed.

Shop practice topics include shop safety, basic hand tools, basic vehicle services including oil changes, fluid inspections, tire and wheel inspection. Students will disassemble a functional small engine, identify components, reassemble and verify the engine runs. This course is also designed to expose students to the Automotive Technology career pathway. This course does *not* cover the diagnosis or repair of vehicles.

Course Requirements – Completion of graded assignments. Participation during small engine unit.

Grading Policy Description – Students will be graded based on the following: participation, text book assignments, web-based assignments, open note quizzes, oral and written tests.

The ONLY grade that matters is what is posted in Synergy (Parentvue/Studentvue). There will be grades in Schoology but not all Schoology grades will be posted in Synergy and there will be other things not in Schoology posted in Synergy.
